Further, I am aware that missions travel involves certain risks, including but not limited to death, personal injury, and property damage resulting from accidents, sickness, the uncontrollable nature of the encounters with other persons that may occur, and situations in the country(s) being visited, such as civil unrest, epidemics, and unstable governments. In addition, I understand that participation in missions travel may involve sites that may be remote from available medical assistance. I agree that the program sponsors cannot guarantee my total safety since some risks are beyond their control. I agree to follow all instructions and guidelines given by them, and to act in a safe and responsible manner toward all participants and the others I come in contact with. I am voluntarily participating in this activity with knowledge of the danger and hereby agree to accept any and all inherent risks of property damage, personal injury, or death.

I further agree to indemnify and hold harmless Memphis Athletic Ministries, Fellowship Bible Church and others listed for any and all claims arising as a result of my participation in mission activities or any activities incidental hereto, wherever, whenever, or however the same may occur.
